#### 1. COMPLIANCE REQUIREMENTS

1.1.1 As a public entity, Fasset has both the obligation and the responsibility to ensure that it spends the public money, with which it is entrusted in a manner that meets governments requirements. Consequently, Grant Applicants are required to adhere to the compliance requirements as listed in this section.

#### **Fraud and Corruption**

1.2.1 All grant applicants are to take note of the implications of contravening the Prevention and Combating of Corrupt Activities Act, 2004 (No 12 of 2004) and any other applicable act.

# B-BBEE Certificate, Tax Clearance Certificate and Professional Body Registration

- 1.3.1 All grant applicants are to provide a B-BBEE status level certificate and the Tax Clearance Certificate (SARS pin) on request once Fasset has granted provisional approval.
- 1.3.2 Grant applicants will be assessed based on the compliant requirements with the BBBEE and tax compliance. Fasset reserves its right to award or not to award to applicants with BBBEE level status above level 4.

#### INDEPENDENT GRANT SUBMISSION

1.3.4 Grant applicants must complete and sign the Certificate of Independent Grant Submission, which can be found in Annexure. The signed certificate must be included in the grant submission. The purpose of the certificate is to prevent potential collusion amongst applicants.

- 1.3.6 Grant applications received by FASSET after the closing date shall not be considered.
- 1.3.7 Grant Applicants are required to submit their Proposal which contains, at minimum:
  - 1.3.7.1 Experience of Grant applicant
  - 1.3.7.2 Technical approach/ Methodology.
  - 1.3.7.3 Experience of the Team; and
  - 1.3.7.4 Pricing schedule.
- 1.3.8 Fasset reserves the right to guery a pricing schedule as part of the evaluation process

#### 2. GRANT CRITERIA (Terms of Reference)

The grant criteria should <u>please</u> be read <u>carefully</u> and adhered to minimize grant queries. The following criteria are applicable to this grant:

# **Description:** Monitoring and Evaluation of Discretionary Grants that achieve the following:

- The monitoring and evaluation of the Fasset projects funded through discretional grants to ensure proper implementation of the projects.
- Conduct due diligence on Fasset projects funded projects before implementation and assess transformation imperatives- e.g. enterprise development
- Conduct an integrated and comprehensive tracing and tracking study
- Perform an Impact assessment of the grants awarded.

#### 2.1 OVERALL OBJECTIVES AND SCOPE

- 2.1.1 This discretionary grant project: Monitoring and Evaluation of the Fasset projects funded through Discretionary grants.
- 2.1.2 Fasset aims to introduce an independent and effective monitoring and evaluation mechanism on discretionary grants funded programmes, which is essential to the achievement of skills development mandate.
- 2.1.3 Monitoring and evaluation should be a due diligence and feedback tool sustainable that will be used to improve the implementation of the Fasset programmes.
- 2.1.4 Integrated and comprehensive tracing study which incorporates results into the assessment study to be completed at the end of the cycle.
- 2.1.5 Grant applicant should conduct extensive sites visits to monitor and evaluate the implementation and/or roll out of the DG funded projects.
- 2.1.6 Review current Seta policies and procedures and DG criteria for further development of the Fasset M&E Framework.
- 2.1.7 Develop a monitoring and evaluation tool as well as the reporting tool.
- 2.1.8 Analyse and report the findings/results and make recommendations to FASSET on M&E implementation and impact assessment.
- 2.1.9 Prepare adhoc reports per programme as when requested based on the monitoring and evaluation exercise.
- 2.1.10 Training and transfer of skills on the tools utilised for monitoring and evaluations.
- 2.1.11 The programme must be implemented and completed within a period of 36 months from the date of appointment.
- 2.1.12 The programme must achieve M&E of at least 80% of the discretionary grants funded projects over the period. Failure to meet this objective will result in a penalty on the project management fee.
- 2.1.13 Awarding and contracting should be done before 31 March 2022.

# Project Reporting requirements

- 2.1.14 Accurate records of all the Fasset projects monitored and evaluated should be maintained.
- 2.1.15 Monitoring and evaluation reports per each assignment maintained
- 2.1.16 Approved implementation plan for site visits maintained
- 2.1.17 Close-out reports maintained.
- 2.1.18 Grant applicants will be required to present information on a monthly or quarterly basis as per Fasset requirements. The required information includes but is not limited to:
  - 2.1.18.1 Attendance registers:
  - 2.1.18.2 Proof of site visits and photographic evidence
  - 2.1.18.3 Ad hoc reports as when required;

# **DETERMINATION OF SCORE FOR FUNCTIONALITY AND GRANT ADJUDICATION**

- 3.1.1 Should a grant applicant achieve a functionality score that is 50% or less, the grant application will be rejected.
- 3.1.2 Should a grant applicant receive a functionality score between 51% and 69%, Fasset might engagewith the applicant on the grant application.
- 3.1.3 All grant applications that receive a functionality score of more than 70% will be recommended for adjudication.
- 3.1.4 Grant applicants should indicate if this is the first time proposing such a project.
